Submission Requirements and Process: PAPERS AND CASES

- Authors must designate a division/track for submissions in the online submission system.
- Submissions must be entirely original and must not be under concurrent consideration or scheduled for presentation elsewhere.
- Submissions must be typed, double-spaced with one-inch margins using 12-point Times Roman font in a Word or PDF file.
- Submissions from students should be noted as such when author information is entered into the online submission system.
- Submissions must include an abstract (no more than 100 words) and an executive summary (no more than 300 words). The executive summary should provide a synopsis of the findings, implications for theory and practice, and how the findings can be implemented.
- All submissions must include a “So what?” section (prior to the “Conclusion” section), where the contribution to the field is addressed.
- Teaching cases may be based upon a primary or secondary data source reflecting the situation of an actual organization. Teaching case submissions must be accompanied by an instructor’s manual or teaching note.
- The entire paper or case, including the abstract, executive summary, references, and figures, cannot exceed 30 pages.
- All submissions will be blind reviewed. Authors must avoid revealing their identity in the body of the paper.
- Selection for inclusion in the conference program will be based upon quality, originality, and relevance in the judgment of at least two independent reviewers. Reviewers will be directed to look for the “So what?” issue.
- Authors having papers accepted for presentation must agree to follow a specific format in preparing MS Word files of a one-page academic abstract along with the executive summary and full paper by November 1, 2007. Detailed instructions will be provided with the acceptance notice. The USASBE 2008 Proceedings will be in CD-ROM format.

All papers and cases must be submitted via an online submission system at <http://usasbe.org>. You may access the online submission system starting June 2007, and the deadline for submission is August 15, 2007.

Submission Requirements and Process: WORKSHOPS AND SYMPOSIA

- Presenters must designate a division/track for submissions in the online submission system.
- Submissions must be typed, double-spaced with one-inch margins using 12-point Times Roman font in a Word or PDF file.
- Submissions must include an abstract (no more than 100 words) and an executive summary (no more than 300 words). The executive summary should provide a summary of the purpose and outcomes to and expected outcomes of the workshop or symposium.
- Workshop and symposia submissions can be no more than 10 pages. Submissions must provide details on the purpose, procedures, and contributions of each participant.
- All submissions must include a “So what?” section prior to the “Conclusion” section. This section should address the workshop or symposium’s contribution to the field.
- Selection for inclusion in the conference program will be based upon quality, originality, and relevance in the judgment of at least two independent reviewers. Reviewers will be directed to look for the “So what?” issue.
- Presenters having workshops or symposia accepted for presentation must agree to follow a specific format in preparing a Word file of a one-page academic abstract along with the executive summary and full paper by November 1, 2007. Detailed instructions will be provided with the acceptance notice. The USASBE 2008 Proceedings will be in CD-ROM format.

Workshop and symposia submissions must be submitted via an online submission system at <http://usasbe.org>. You may access the online submission system starting June 2007, and the deadline for submission is August 15, 2007.

IMPORTANT NOTICE: The USASBE 2008 Conference will utilize a “Rule of 3” for submission purposes. No one may submit more than three (3) competitive submissions (papers and/or workshops/symposia) to the USASBE Conference or appear in more than three (3) competitive sessions during the refereed scholarly program. Appearances include roles as authors and/or presenters. Exceptions will be made for invited workshops/symposia, officer roles, and general and division meetings.

Attendance Requirements

At least one paper or case author and all workshop and symposium presenters of accepted submissions are required to register and attend the USASBE 2008 Conference. Conference registration fees for authors and presenters of all accepted submissions must be paid by November 1, 2007. Failure to pay fees by this date will result in the deletion of the submission from the program.
